- Criteria established and standard for GPE Grant Agent Candidate was distributed for all member Development Partners who Participated of ACETL
- The deadline for submission set for 27 April 2016, addressed to Director General for Policy, Planning and Partnership, Mr. Antoninho Pires

## Response....

- Having circulated the form for evaluation and request for the expression of interest as of 27 of May (one month), only the World Bank submitted its expression of Interest on 27 May 2016.

## Endorsement

- The whole process of GPE to select Grant Agent according to GPE guidelines was carried out openly and transparently.
- Consultation process was carried out in accordance with the GPE guidelines
- Government priorities has been identified and will be adjustable in accordance with the Grant Agent sector Review
- Solicitation of interest was conveyed through ACETL meeting.
- A single expression of interest from the World Bank
- The government has decided to appoint the World Bank as the Grant Agent for the GPE fund.
- The Ministry request endorsement from the forum of ACETL.



## Note:

- For the purpose of documentation, we encourage the Bank to submit the remaining documents highlighted in the evaluation form after the endorsement so that they can be posted on the ACETL website and serve as evidence of the process.
- Next step, the Sector review will be carried out by the Grant Agent in close consultation with the structure within the Ministry and regular update with DPs for comments and inputs in the ACETL meeting.
